Three hundred and fifty delegates from all nine provinces descended on Mitta Seperepere Convention Center in Kimberley to witness the first South African Heroine Awards (SAHA) in the Northern Cape.

Hosted on Women's Day, the Convention Centre was filled with men and women dressed to the nines.

Thanks to the Mme Re Ka Thusa Trust Fund, the 14th edition of SAHA was the Northern Cape's turn to host this prestigious event, queens such as Kediemetse Bogaleboile, Gladys Matshele, Kedidaletse Williams and Masego Job, to mention a few, were previously awarded in other provinces.

Participants are nominated in various categories and thereafter, the public is invited to vote.

On Women's Day, 35 recipients from different walks of life were awarded certificates of recognition. As tradition, five candidates who receive the highest number of votes are honoured with black

The 1st Deputy Secretary of the ANC, Nomvula "Mama Action" Mokonyane, took the opportunity to educate the audience about the struggle that women went through and the significance of Women's Day. "Women's Day is what it is because of special women like Mittah Seperepere. When they returned from exile in 1991 at the ANC conference in Durban, they made a call that once we are in power, August 9 must be a holiday. It's not a holiday just to do laundry, it's a day to share and celebrate each other and our freedom, even though we are not liberated, "she alluded.

"Of course, things are not that good yet in our country, but nobody said things would be done and dusted within 30 years when we have been oppressed for over 400 years. My motivation to you all is that today is better than 1956, and tomorrow will be better than 2025 because of all of us. We need to appreciate young South Africans. After your turn, mine will come. Let's celebrate Caroline, she is our Albertina Sisulu," she continued.

The current second lady of the country, Humile Mashatile, also took the stage and continued teaching delegates about the challenges faced by parents with autistic children. "People living with autism do not get the support they deserve. The community needs to understand autism; they should know that an autistic child's brain is wired differently", she said.

SAHA was founded by Caroline Mosiamo in 2012. It is registered as a non-profit organisation. The organization's objective is to celebrate and support women. Since its inception, the NPO has annually acknowledged women across various spectrums throughout the country.

Mosiamo applauded the Northern Cape government, especially MECs Venus Blennis-Magage and Mase Manopole, for their involvement. "I've been presenting these awards for 14 years, and it was pleasant to receive a call from the MEC, ensuring that everything went well". She also thanked Glady Matshele, CEO of Mme Re Ka Thusa Trust Fund, for initiating this collaboration.

Legal Aid saves family from eviction

A significant victory was secured for a family in the Barrydale area in the Western Cape after they successfully opposed their eviction. On 5 August 2025, the Land Court in Cape Town handed down judgment dismissing an appeal by a landowner who sought to overturn the decision of the Swellendam Magistrate's Court which dismissed their application for an eviction against the occupiers.

The eviction was sought against a family comprising two main occupiers (husband and wife), their daughter who has a physical disability and two minor children. The wife was born on the farm while the husband started staying at the farm in 1989. With the exception of the husband, all other parties were born on the farm.

The married couple previously worked at the farm. The wife had to resign in 1998 to take care of their daughter who was living with physical disability and the husband stopped working in 2020 as his employment was terminated.

The landowner's contention was that since the husband was no longer employed at the farm, the family's occupation must be terminated. The Extension of Security of Tenure Act allows landowners to terminate occupation of farm occupiers when they no longer work at the farm, provided employment was the sole reason for the farm occupier to live on the farm in the first place.

landowner is required to not only rely on the absence of employment to terminate the residence of occupiers but must also consider all relevant factors such as conduct between themselves and the occupiers, the hardships each party will suffer in the instance of termination or lack thereof, the period of occupation, especially if there would be a reasonable expectation of extending the occupation, and agreements between the parties.

Before the termination is done, the farm occupier is generally given an opportunity to explain their circumstances in relation to their occupation and circumstances after termination. Both the Magistrate's Court and Land Court found that the landowner had not complied with the requirements above that justify termination.

The Land Court dismissed the appeal by the landowner without making any order as to costs.

From the Magistrate's Court to the However, even in such instances, the Land Court, the occupiers were represented by Legal Aid SA's lawyers Mvuyisi Mjuda, Lelethu Mgedezi and Hilary Julius from the Stellenbosch Local Office. The Legal Aid SA Northern Cape/Western Cape Provincial Executive Nolitha Jali stated that this matter is one of many similar cases in the province where vulnerable occupiers such as women, people with disabilities and children face eviction despite having occupied farms for many years and having nowhere else to go.

Minister Motsoaledi commits to supporting the Northern Cape to address healthcare service delivery challenges

Minister Motsoaledi has on Friday, 08 august visited the Northern Cape province following the release of the report by the Health Ombud on his investigation of treatment, complications and deaths of psychiatric patients at Northern Cape Mental Hospital and Robert Mangaliso Sobukwe Hospital.

On the 30 July 2025, the Health Ombud called a Press Conference to release a report about his findings on the investigations done at the Northern Cape Mental Hospital and Robert Mangaliso Sobukwe Hospital, also in the Northern Cape.

The investigation was prompted by the Minister of Health, Dr Aaron Motsoaledi, requesting the Health Ombud to do an investigation after the deaths of two mental health users at the Northern Cape Mental Health Hospital.

On the day that the Report was released, the minister promised that he would personally go to the Northern Cape to meet the management of the province, including the Premier Dr Zamani Saul, Health MEC Maruping Lekwene, Finance MEC Venus Blennies-Magage, management of the Department of Health to discuss some of these findings.

By and large, the findings have to do with issues of Human Resources (HR) issues, Procurement, Clinical Protocols and Practices, inside the Hospitals themselves.

In the report, some health workers including doctors and nurses, were fingered for not having performed certain professional clinical functions with diligence.

After the initial meeting, where the Minister met the Premier, the MECs for Health and Finance, the Director-General of the Province, with their officials, it was then agreed that all the Labour Unions had to be met.

The Minister therefore met five (5) Labour Unions including DENOSA, HORSPERSA, NEHAWU, PSA and NUPSAW, and reported to them the purpose of the trip and the findings of the Health Ombud, and what is going to happen going forward.


The Labour Unions pointed out that they are unhappy about the manner with which the Health Ombud has fingered some of their members, and they wanted the Minister to look into that. The Minister then informed them about the correct procedures in

terms of the Health Ombud Report, that the Minister is not an Appeals Authority of the Health Ombud and therefore he cannot review his Reports.

The Minister further indicated that the law prescribes that once a person lodges an appeal, he (Minister) must set up a three-member Tribunal to be chaired by a retired Judge or a Retired Magistrate. The other two members may either be health professionals or legal professionals. Minister has therefore, advised labour unions that anyone who is not happy, this standard procedure must be followed.

Minister Motsoaledi also briefed the Labour Unions about what the health sector is going to do to improve issues of staffing, procurement of beds and linen, the hiring of health workers, etc.

The visit ended with a site-visit to the hospitals for the delegations to see for themselves some of the findings of the Health Ombud, and to acclimatise themselves in the shortest way possible, to try and implement the recommendations of the Health Ombud Report.



President Ramaphosa to announce a national cleanup day

President Cyril Ramaphosa will designate a specific day for a nationwide cleanup, with all South Africans, including Ministers, participating in community cleanup efforts, Deputy President Paul Mashatile said. "We'll dedicate time on the day that the President will indicate that at least on that particular day, for particular hours in the day, we work with our communities, and we clean," the Deputy President said

This as he visited the Mangaung Metropolitan Municipality in the Free State as part of the Clean Cities and Towns Campaig

The Deputy President officially unveiled a comprehensive national cleaning initiative aimed at transforming community hygiene and infrastructure maintenance in the province. The campaign is an integrated service delivery initiative that was officially launched in Kliptown, Soweto, in June of this year

It aims to promote cleaner, healthier, and more sustainable environments in both urban and rural areas. The campaign encourages community involvement in cleaning their surroundings, working collaboratively with district and local municipalities.

The Mangaung leg of the campaign was held under the theme: "Bontle Ke Botho: A Free State that works for all – Building clean and sustainable communities."

The campaign emphasises a collaborative approach across national, provincial, and local government levels, highlighting the campaign's multifaceted strategy

"We're not just picking up papers. This campaign is going to be combined with repairing and modernising things, dealing with challenges of potholes, fixing roads and repairing infrastructure," Deputy President Mashatile told the community.

According to the country's second-incommand, the initiative also includes several critical components, including weekly dedicated cleaning days and school engagement to instill a cleanliness culture

"We also went to visit schools to encourage our young children to inculcate this culture of clean-up. So, it's going very well today," he said.

Meanwhile, the Deputy President said government plans to address municipal challenges, recognising that many local authorities struggle with limited economic resources.

"Some municipalities are not able to perform critical services because they don't have an economic base." The campaign represents a "whole of government approach," aiming to create a unified responsibility for maintaining clean, functional urban and rural environments.

The initiative is expected to roll out across provinces to transform South Africa's approach to community maintenance and civic responsibility.

St Augustine's was on point when he coined the phrase, "singing is praying twice." Kimberley Deanery Catholic Choirs held their annual Liturgical Competition at St Boniface on 9 August.

The audience was revived and happily sang along to hymns and choruses rendered by St Peter's, Our Lady of Fatima Shrine, St Boniface, 14 Streams District Choirs, and the Kimberley Deanery Youth Choir under the baton of a young and talented Bradley Mankwe.

Secretary for Kimberley Deanery Catholic Choirs Peggy Kompe said: "The objective of the competition is to purify our liturgy and to rearrange our hymns. The competition is divided into two categories and is based on our Liturgical Calendar. For this year, we chose the Advent season, hence the first song is hymn 62 in our Hymn Books, followed by the confession and Our Father. The second category is Offertory, choirs are expected to sing one hymn and a chorus".

A popular chorister, who grew up in the choral music scene and graduated to the role of adjudicator, Kgololo a.k.a Mazaza Hlakudi, praised the Catholic Church for this initiative. He said competition makes a choir improve because it puts them under pressure. Hlakudi encourages other churches to follow the competition route to enhance the love of choral music.

St Peter's conductor, Perpetual Mogamisi, a veteran in choral music, shared some challenges, "Most choir members are between 70 and 85 years, especially the back line. This makes it difficult for me because sometimes they forget what we practiced. They also belong to other sodalities within the church, making it difficult to attend practice regularly."

Africa's own Dr Phil

A Congolese-born Doctor, Phil Mwenze, is Senior Medical Officer (Physician) at Robert Mangaliso Sobukwe Hospital and also running a private practice in Roodepan.

He came to South Africa 18 years ago. He worked in Johannesburg for eight years before relocating to Kimberley.

Dr Phil stated that in their country, many companies had their clinics or hospitals. He and his siblings used to visit his father's workplace, an entrepreneur.

"I was eight (8) years old when I decided to be a doctor. I liked the respect shown to the profession. There was this one particular Doctor who drew my attention. I liked how he was and his charisma was everything to me", said the only Doctor out of 13 siblings. Most of his siblings followed in their father's footsteps, going into business or managing the family's wealth.

He commented on the scourge of TB in the province. "Some illnesses are environmental or lifestyle oriented. The Northern Cape has a high level of TB" he remarked.

He said the reason for his relocation to South Africa is that he needed to practice his profession and serve people without any political interference. However, it was a struggle for him to obtain all the relevant documents that allowed him to work in the country.

His family later joined him. He is a husband to an entrepreneur, Aena and a father to four boys. He enjoys board games and spending time with his family.

Four arrested for property related crimes in Pixley ka seme

Operation Basadi continues to intensify its efforts to combat property-related crimes across the Northern Cape, with increased police visibility during Women's Month 2025.

In the Pixley Ka Seme District, members of the Public Order Police (POP) Unit in De Aar, while conducting patrols under Operation Basadi in the Sunrise area, acted on intelligence regarding the possession of suspected stolen copper by three foreign nationals at a local dumping site.

Upon arrival, the suspects attempted to flee in different directions. Police officers gave chase and successfully apprehended all three individuals.

Copper cables, valued at approximately R3 428.10, were seized.

The suspects were arrested and charged with damage to essential infrastructure and for contravening immigration laws.

In a separate incident, Britstown police responded to a reported housebreaking and theft.

Acting on information received, officers traced a suspect to a residence in Britstown. A search of the premises led to the recovery of a stolen television, electronic equipment, and groceries.

A26-year-old male suspect was arrested. All suspects will appear in their respective Magistrates' Courts in due course.

The Pixley Ka Seme District Commissioner, Major General Nomana Mtukushe, reaffirmed the police's commitment to maintaining heightened visibility during and beyond Women's Month. She emphasized that community support is vital in enhancing police efforts to safeguard lives and property.

The continued partnership between the community and the police remains instrumental in fighting crime.

On 25 September 2022, at approximately 08:00, a 34-year-old woman was in Tlhageng in Galeshewe, in the company of a male friend.

The two received a lift and were dropped off at the male friend's residence in Tlhageng, where they spent the night.

The next morning, the male friend informed the victim that she should continue resting while he went home to fetch his vehicle to take her back to her residence.

After he left, the accused, who is a friend of the male companion, entered

the bedroom where the victim was sleeping and forcefully raped her.

The victim opened a case, and the accused was subsequently arrested.

The case was assigned to Detective Constable Beverly Matlhale of the Galeshewe Family Violence, Child Protection and Sexual Offences (FCS) Unit.

The Galeshewe Regional Court recently convicted the accused, Boitumelo Isaac Mokhele (38), and sentenced him to ten (10) years' direct imprisonment for rape.

The SAPS Northern Cape Management welcomes the conviction and sentence and commended Detective Constable Matlhale for her excellent investigative work, which led to the successful prosecution and removal of the perpetrator from society for a significant period.

Kagisho rapist sentenced to eight years' imprisonment

Galeshewe man sentenced for ten years for rape

The Galeshewe Family Violence, Child Protection and Sexual Offences (FCS) Unit has secured an eight-year direct prison sentence for 55-year-old Boitumelo Simon Mokomela, handed down by the Galeshewe Regional Court following the rape of a 26-year-old female victim on Sunday, 18 September 2022 in Galeshewe.

According to court proceedings, the victim and her boyfriend were asleep when the victim awoke to find someone raping her.

Upon opening her eyes, she recognised the perpetrator as her boyfriend's uncle. Realising that she was awake, the accused immediately fled into another room. The victim alerted her boyfriend and subsequently reported the incident to the police.

The accused, Boitumelo Simon Mokomela, was arrested, convicted of rape, and sentenced to eight years' imprisonment.

The court further directed that the offender's name be entered into the National Register for Sex Offenders and declared him unfit to possess a firearm.

The Frances Baard District Commissioner, Major General Charlotte Makgari, commended Detective Warrant Officer Tanya Serfontein for her dedication, expertise and professionalism in ensuring justice for the victim and reinforcing the fight against gender-based violence.

Marydale accused receive additional jail time for related offences

Selby George (35), who was recently sentenced to two life terms for the brutal rape and murder of 21-year-old Thobeka Bosman in Marydale, has now received additional sentences for related crimes.

The Kimberley High Court imposed a further seven (7) years for attempted rape and one (1) year for assault with intent to cause grievous bodily harm in a separate incident.

The additional charges stem from an incident on 02 March 2019 at approximately 22:00, when George attempted to rape a 37-year-old woman and severely assaulted her at a residence in Marydale.

A female friend of the victim managed to escape and alerted the police.

Officers responded swiftly and arrested George at the scene.

The sentences for attempted rape and assault GBH were handed down on 01 August 2025 and will run concurrently with the existing life sentences.

In a separate case, George was

acquitted of rape and assault charges involving a 36-year-old woman in Marydale on 22 December 2018. All the victims were known to the accused.

The District Commissioner for Pixley Ka Seme, Major General Nomana Mtukushe, praised Detective Sergeant Riaan Van Wyk of the Prieska Family Violence, Child Protection and Sexual Offences (FCS) Unit for his exceptional investigative work. She also acknowledged the strong collaboration with Advocate Katrien Jansen and Advocate Ters Engelbrecht, whose prosecutorial efforts contributed to the successful conviction.

This outcome sends a clear and strong message that Gender-Based Violence and Femicide (GBVF) will not be tolerated in the Northern Cape—especially as we commemorate Women's Month.

Let us continue to unite in the fight against the scourge of GBVF.
